Thank you for your interest in Toledo Rowing Club's summer rowing program, **SumPro**. Please take a moment to review the registration information below and complete the attached forms as instructed.

1. Please complete the attached registration form in its entirety. Early registration is appreciated.
 - A. All classes will begin at 5:28 p.m. at the TRC boathouse and last about one and one-half hours to two hours.
 - B. For those taking sculling classes, everyone will be expected to attend a demonstration of how to get back into a rowing shell (our boats) from the water. This recovery drill will be held in a clean freshwater pond and not in the Maumee River. The drill will be scheduled on a Saturday with a date to be determined in the near future.
 - C. For sculling students, the other three Saturday mornings will be open rowing supervised by TRC members, but without formal instruction.
 - D. Please don't forget to enter your date of birth and E-mail address (if you have one) on the form as well.
 - E. Check the appropriate box (one only) for your choice of sculling only (\$100), sweep only (\$100), or both (\$180).
2. Please complete the attached waiver as instructed on the form. Every SumPro student must complete and submit this waiver. Note that if the SumPro student is under 18 years of age, a parent or guardian must complete the section at the bottom of the form.
3. Make your check or money order for either \$100 or \$180 payable to "Toledo Rowing Club", along with noting "SumPro" on the memo line.

If you are under 18 years of age, you will be required to have a parent or guardian sign the parental waiver form or you will not be allowed to participate in the class.

WAIVER

IN CONSIDERATION of being given the opportunity to participate in any Toledo Rowing Club and Toledo Rowing Foundation ("Club") activities ("Activity") until the end of this calendar year, I, for myself, my personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree and represent that I understand the nature of Rowing Activities, both on water and land based, and that I am qualified, in good health, and in proper physical condition to participate in such Activity.

FULLY UNDERSTAND that: (a.); ROWING ACTIVITIES INVOLVE RISKS AND DANGERS of serious bodily injury, including permanent disability, paralysis and death ("Risks"); (b.) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or the negligence of the Releasees names below; (c.); there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the Activity.

AGREE AND WARRANT that I will examine and inspect each Activity in which I take part as a member of the Club and that, if I observe any condition which I consider to be unacceptably hazardous or dangerous, I will notify the proper authority in charge of the Activity and will refuse to take part in the Activity until the condition has been corrected to my satisfaction.

HEREBY RELEASE, discharge, and covenant not to sue USRowing, the Club, their administrators, directors, agents, officers, volunteers and employees, other participating regatta organizers, any sponsors, advertisers, and if applicable, owners and lessors of premises, on which the Activity takes place, (each considered on of the Releasees herein) from all liability, claims, demands, losses or damages on my account caused or allege to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS each of the Releasees, from any litigation's expenses, attorney fees, loss, liability, damage, or cost which any may incur as a result of such claim.

I have read this agreement, fully understand its terms, understand that have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
